Wednesday, 21 September 1977

THE SECOND LEGISLATIVE ASSEMBLY assembled in the Legislative Assembly Chamber at 1000 hours on Wednesday 21 September 1977, being the first day of the meeting of the Second Assembly for the dispatch of business pursuant to the Notice set out hereunder:

THE NORTHERN TERRITORY OF AUSTRALIA

Northern Territory (Administration) Act 1910

LEGISLATIVE ASSEMBLY FOR THE NORTHERN TERRITORY

WHEREAS, by section 4M(1) of the Northern Territory (Administration) Act 1910, it is provided amongst other things that the Administrator may appoint such times for holding the sessions of the Legislative Assembly as he thinks fit:

NOW, THEREFORE, I, JOHN ARMSTRONG ENGLAND, the Administrator of the Northern Territory of Australia, in exercise of the power conferred by the said Northern Territory (Administration) Act 1910, do, by this notice, appoint Wednesday, the twenty-first day of September, 1977, as the day for the Legislative Assembly for the Northern Territory to assemble and be holden for the dispatch of divers urgent and important affairs and all members of the said Legislative Assembly are hereby required to give their attendance accordingly in the building known as the Legislative Assembly Chamber at Darwin at the hour of ten o'clock in the forenoon on the twenty-first day of September, 1977.

3. ELECTION OF SPEAKER: The Acting Clerk presiding, Mr Everingham proposed to the Assembly for its Speaker, Mr MacFarlane and moved -

That the Honourable Member for Elsey do take the Chair as Speaker.

Mr Perron seconded the motion and Mr MacFarlane informed the Assembly that he accepted nomination.

Mr Isaacs proposed to the Assembly for its Speaker Miss D'Rozario and moved -

That the Honourable Member for Sanderson do take the Chair as Speaker.

Mr Perkins seconded the motion and Miss D'Rozario informed the Assembly that she accepted nomination.

The time for proposals having expired -

Mr Everingham and Mr Isaacs spoke in support of their proposals.

Bells rung and ballot conducted.

The Acting Clerk announced the result of the ballot: Mr MacFarlane 12 votes, Miss D'Rozario 7 votes, and declared Mr MacFarlane elected to the office of Speaker in accordance with standing order No. 5.

Mr MacFarlane thanked the Assembly for the honour it had conferred upon him and thereupon sat in the Chair.

4. ATTENDANCE OF HIS HONOUR THE ADMINISTRATOR: Mr Speaker and Members of the Assembly were received by His Honour the Administrator within the precincts of the Assembly.

Mr Speaker presented himself as the choice of the Legislative Assembly to His Honour the Administrator who congratulated him upon his election and handed to Mr Speaker his Commission to administer oaths and affirmations.

Mr Speaker and Members returned to the Chamber.

5. COMMISSION TO ADMINISTER OATHS: Mr Speaker announced that he had received from His Honour the Administrator the following Commission which was laid on the Table:

His Honour the Administrator entering the Chamber, Mr Speaker left the Chair and His Honour delivered, from the Chair, a speech declaring the causes of his calling the Assembly together.

His Honour then left the Chamber.

7. EXECUTIVE MEMBERS AND THEIR FUNCTIONS - STATEMENT: Mr Everingham, by leave, made a statement relating to the designations of Executive Members and the functions for which they would be responsible.
8. OPPOSITION OFFICE HOLDERS - STATEMENT: Mr Isaacs, by leave, made a statement relating to the office holders in the Opposition.
9. ALICE SPRINGS ADMINISTRATION REPEAL BILL 1977 (Serial 12): Mr Robertson, by leave, presented the Bill which was thereupon read a first time.
- On the motion of Mr Robertson the second reading was made an order of the day for a later day.
10. ADDRESS IN REPLY: Mr Everingham presented an Address in Reply to the Administrator's speech in the following terms:

MAY IT PLEASE YOUR HONOUR -

We, the Legislative Assembly for the Northern Territory, in Assembly assembled, desire to express our loyalty to our Gracious Sovereign, and to thank Your Honour for the Speech which you have been pleased to address to the Assembly,

Mr Everingham moved -

That the Address be agreed to.

Mr Isaacs seconded the motion.

Debate adjourned and the resumption of the debate made an order of the day for a later hour.

11. DISTINGUISHED VISITOR - THE HONOURABLE ALBERT EVAN ADERMANN, M.P.: Mr Speaker informed the Assembly that the Honourable Albert Evan Adermann, M.P., Minister of State for the Northern Territory, was within the precincts. The distinguished visitor thereupon, with the concurrence of Members, was provided with a seat on the floor of the Assembly.
12. ADDRESS BY MINISTER OF STATE FOR THE NORTHERN TERRITORY: The Honourable A.E. Adermann, M.P., Minister of State for the Northern Territory, at the invitation of Mr Speaker and with the concurrence of Members, addressed the Assembly.
- Mr Speaker, on behalf of the Assembly, thanked the Minister for his Speech.
13. ELECTION OF CHAIRMAN OF COMMITTEES: Mr Everingham proposed to the Assembly for its Chairman of Committees the Member for Casuarina, Mr Dondas, and moved -

That he be so appointed.

Mr Perron seconded the motion and Mr Dondas informed the Assembly that he accepted nomination.

Mr Isaacs proposed to the Assembly for its Chairman of Committees the Member for Victoria River, Mr Doolan, and moved -

That he be so appointed.

Mr Perkins seconded the motion and Mr Doolan informed the Assembly that he accepted nomination.

There being two nominations, Mr Speaker ordered that a ballot be conducted.

Bells rung and ballot conducted.

Mr Speaker announced the result of the ballot as Mr Dondas 12 votes, Mr Doolan 7 votes, and declared Mr Dondas elected to the position of Chairman of Committees.

Members congratulated Mr Dondas, who made his acknowledgements to the Assembly.

14. APPOINTMENT OF STANDING ORDERS COMMITTEE: Mr Robertson, by leave moved -

That pursuant to standing order 15, Mr Speaker, Mr Dondas, Miss D'Rozario, Mr Everingham and Mr Perkins be appointed as the Standing Orders Committee.

Question put and passed.

15. APPOINTMENT OF PRIVILEGES COMMITTEE: Mr Robertson, by leave, moved -

That pursuant to standing order 16, Mr Ballantyne, Mr Doolan, Miss D'Rozario, Mr Harris and Mr Tuxworth be appointed as the Committee of Privileges.

Question put and passed.

16. APPOINTMENT OF HOUSE COMMITTEE: Mr Robertson, by leave, moved -

That pursuant to standing order 17, Mr Speaker, Mr Collins, Mr Dondas, Mrs O'Neil and Mr Vale be appointed as the House Committee.

Question put and passed.

17. APPOINTMENT OF PUBLICATIONS COMMITTEE: Mr Robertson, by leave, moved -

That pursuant to standing order 18, Mr Collins, Mr Doolan, Mrs Padgham-Purich, Mr Steele and Mr Vale be appointed as the Publications Committee.

Question put and passed.

18. APPOINTMENT OF SUBORDINATE LEGISLATION AND TABLED PAPERS COMMITTEE: Mr Robertson, by leave, moved -

That pursuant to standing order 19, Mr Ballantyne, Mr Harris, Mrs Lawrie, Mr Oliver and Mr Perkins be appointed as the Standing Committee on Subordinate Legislation and Tabled Papers.

Question put and passed.

19. DELEGATES TO AUSTRALIAN CONSTITUTIONAL CONVENTION: Mr Everingham, by leave, moved -

That the delegates of this Assembly to the Australian Constitutional Convention be Mr Everingham and Mr Isaacs and that in the event that either delegate is unable to attend the Convention, Mr Robertson act as substitute delegate.

Question put and passed.

20. MESSAGE FROM ADMINISTRATOR: The following message was read by Mr Speaker:

Message No. 1.

I, JOHN ARMSTRONG ENGLAND, the Administrator of the Northern Territory of Australia, pursuant to section 4S of the Northern Territory (Administration) Act 1910, recommend to the Legislative Assembly Bills entitled the Allocation of Funds (Appropriation) Bill (No. 1) 1977-78 and the Allocation of Funds (Appropriation) Bill (No. 2) 1977-78 to make provision with respect to the expenditure of moneys appropriated by the Parliament for operating and capital expenditure for the year ending 30 June 1978 in respect of matters specified under section 4ZE of the Northern Territory (Administration) Act 1910.

Thursday, 22 September 1977

1. The Assembly met at 1000 hours pursuant to adjournment - Mr Speaker MacFarlane took the Chair.

Mr Robertson, by leave, moved -

That the Assembly notes the statement and commends the Commonwealth Government's decisions on the matters contained therein.

Debate adjourned and the resumption of the debate made an order of the day for a later hour,

8. ASSEMBLY REPRESENTATION ON DARWIN RECONSTRUCTION COMMISSION: Mr Perron laid on the table a statement relating to Assembly representation on the Darwin Reconstruction Commission.

Mr Robertson moved -

That the statement be noted.

Mr Isaacs seeking to move as an amendment: That all words after "That" be omitted and the following be inserted "this Assembly terminates the appointment of Mr G.E. Tambling to the Darwin Reconstruction Commission and appoints Miss J. D'Rozario as its representative on the Darwin Reconstruction Commission.

Mr Speaker ruled the amendment out of order.

Debate ensued.

Question put and passed.

9. NOTICE: Mr Everingham, by leave, gave notice that on the next sitting day he would present the Interpretation Bill (No. 2) 1977 (Serial 6).

That the Assembly, at its rising, adjourn until 1000 hours on Friday, 23 September 1977.

12. LOTTERY AND GAMING ORDINANCE - REPORT: Mr Tuxworth laid on the table a copy of the report of an Inquiry into the Lotteries and Gaming Ordinance previously tabled on 12 July 1977 and moved -

Debate ensued.

Debate adjourned and the resumption of the debate made an order of the day for a later hour.

13. DAYLIGHT SAVING - STATEMENT: Mr Robertson laid on the table a statement relating to daylight saving and moved -

14. DISCUSSION OF MATTER OF PUBLIC IMPORTANCE: Mr Speaker informed the Assembly that Mr Isaacs had proposed that a definite matter of public importance be submitted to the Assembly for discussion, namely: "The High Unemployment Rate in the Northern Territory".

The proposal having received the necessary support -

Mr Isaacs addressed the Assembly.

Discussion ensued,

On the motion of Mr Vale the Business of the Day was called on.

15. ALICE SPRINGS ADMINISTRATION REPEAL BILL 1977 (Serial 12): The order of the day having been read for the second reading -

Mr Robertson moved -

That the Bill be now read a second time,

Debate adjourned and the resumption of the debate made an order of the day for a later hour.

16. ADJOURNMENT: Mr Robertson moved -

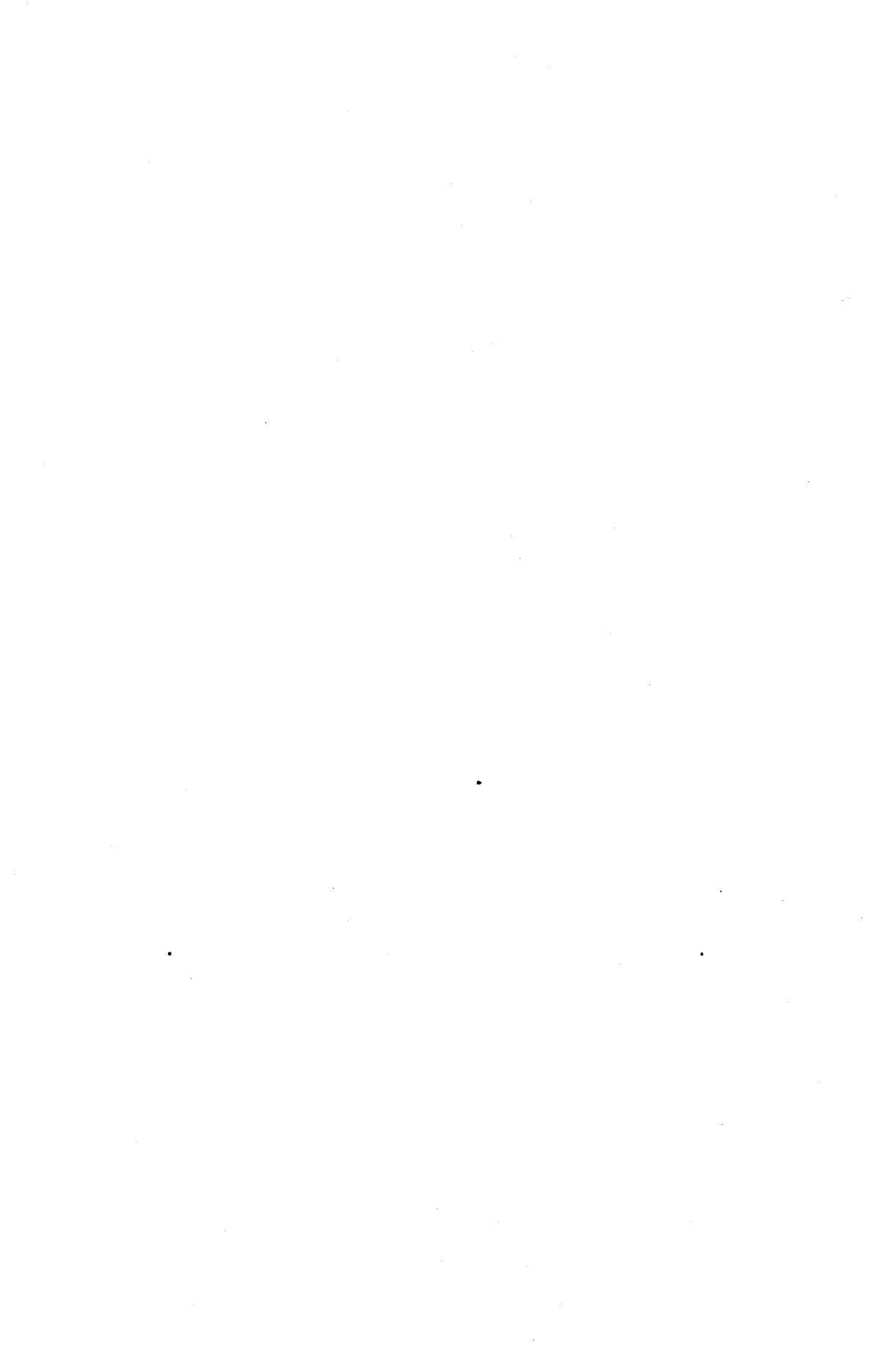
